Events & Awards: 1 Singles & 1 doubles event. All participants play in both. Cash Prizes & or Trophies for 1st & 2nd in all Groups.
Restrictions: No skill or age restrictions. Top and novice skilled players spread equally in first round. **Limited to 25 total participants**
Singles Format: FIRST PRELIMINARY ROUND: Double Round Robin format is 2 ROUNDS of preliminary & playoff matches to determined final results. Known skill, tournaments, club sessions & directors discretion of all players will each pool will consist of a mix of open to novice skill level players. Ideally 5 pools will have 5 players allowing each participant to play a large ranges of skilled players.
SECOND PLAYOFF ROUND: 2nd round robin playoff for each preliminary pool sorted in to groups A-E*. A is Top players, E is lowest level. Your results in the FIRST ROUND will gather 1st place finishers of each pool in Group A, 2nd place to group B, 3rd to group C, 4th to group D and 5th place to group E. Number of pool will vary depending on number of entries.
Rules & Check-in: Check in by 9:45AM at control desk. Games to 11 points, must win by 2 pts. Matches will be best 3 of 5 games. Good sportsmanship is expected. All USATT & ITTF rules apply. Decision of tournament director is final.
Entry Deadline: Friday, 1/2/15 by 11:59PM. Full entry form & FEES must be received by deadline to avoid late fees. Entries received after this date/time will only be accepted based on available space.

Doubles: Top players will be paired with novice players and intermediate players with like skilled players. Single elimination format & consolation playoff for 1st round losers. Attempt to evenly match teams.
